Official Rules

Sweepstakes may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. You have two (2) options for entering: One (1) sign up to receive email updates about Cassandra Clare and more from Simon & Schuster or Two (2) enter a valid mailing address into the online form. All entrants must have a valid email address and must submit mailing address upon entry of sweepstakes. Mailing address will only be use in the event that you win and the prize will be shipped directly.

All entrants must have a valid email address. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned.
